2016-17 TUITION AND MANDATORY FEES DETAILS

Student tuition and mandatory E&G fees are required student charges supporting instruction and related educational activities included in the Educational and General (E&G) program. E&G subprograms include instruction, research and public service, academic support, student services, institutional support, and operation and maintenance of the physical plant. Tuition is assessed in four categories: in-state undergraduate, out-of-state undergraduate, in-state graduate and out-of-state graduate. A full-time rate is set for both in-state and out-of-state undergraduate students who are enrolled in 12 to 17 credit hours of instruction per semester. Per credit hour rates are set for undergraduate students enrolled in less than 12 credit hours or taking more than 17 credit hours per semester and for all graduate students. Out-of-state students are required to cover at least 100% of the average cost of education. A mandatory technology fee is assessed to all students to support the purchase of equipment and software. All out-of-state students are assessed a capital fee to support their share of debt and operating expenses for E&G facilities.

The **comprehensive fee** is a mandatory student charge used to support non-instructional activities and programs in Auxiliary Enterprises such as intercollegiate athletics, recreational and intramural activities, student and cultural activities, health services, student union, facility maintenance and debt service. It is assessed to all students, does not distinguish between in-state and out-of-state students and is considered a mandatory non-E&G fee.

The sum of Tuition and Mandatory E&G fees and the Comprehensive Fee is referred to as *Tuition and Mandatory Fees*.

Room and Board fees are optional charges used to support residence halls and dining functions. Students living off campus are exempt from these fees. At CNU, all freshmen, sophomores and juniors are required to live on campus unless living at home in the following cities: Newport News, Hampton, Poquoson, Yorktown, Seaford or Grafton. Board fees are assessed to all residential freshmen, to those without kitchens in their suites, and to all other students who elect to participate in a meal plan.
