A. PURPOSE

Christopher Newport University is committed to educating students on human trafficking awareness and prevention. This policy describes the ways in which new undergraduate students receive trauma-informed training focusing on the recognition, prevention, and reporting of human trafficking.

B. POLICY STATEMENT

The Office of Orientation and Student Involvement shall provide annually, as part of the university's new student orientation program, training on the recognition, prevention, and reporting of human trafficking. These training programs shall also be made available to student clubs and organizations upon request. Student employees, regardless of academic year, may be required by their supervisors to participate in training.

C. DEFINITIONS

New Student — an undergraduate, full-time student that is attending CNU for the first time

Human Trafficking includes:¹

Labor Trafficking — The use of force, fraud, or coercion to compel individuals to work or provide services

Sex Trafficking — The use of force, fraud, or coercion to compel individuals to engage in commercial sex. Inducing a person under 18 years old to perform a commercial sex act is a crime whether or not there is any force, fraud, or coercion.

D. PROCEDURES

1. Training

All new students are required to participate in training during their orientation program. Training shall be focused on recognizing, preventing, and reporting human trafficking. It may be provided in person or online. Student employees, regardless of academic year, may be required by their supervisors to participate in training.

The Office of Orientation and Student Involvement (OSI) shall coordinate the required training and track the completion of training for all new students.

2. Reporting

If you or someone you know is a victim of human trafficking and is in immediate danger, contact University Police at 757-594-7777 or call 911. University Police are available 24 hours a day, 365 days a year.

Concerns other than imminent threats, to include suspicion of human trafficking, may be reported to the following offices. Please note that these offices, with the exception of the University Police, may not provide an immediate response.
